Staff agreed on a three-year agreement in light of potential changes to the parking lot to better accommodate the needs of car rental agencies including a wash facility and on-site car battery charging stations. Mr. Wheeler noted that it was typical that for car rental firms to fund these changes and suggested that staff include language to this affect in the Draft agreement packaged with the RFP. Mr. Ensor congratulated Mr. Brennan on working with Care Access to arrange for a three-year land lease in our gravel parking lot.
