VI. NEW BUSINESS

a. Request For Change of Use – Lot AR24 – Vineyard Tennis Center Inc. Mr. Wheeler stated that the MVAC had received a written request to approve a request for change the Permitted Use and that our attorney had spoken with the potential assumer who stated that there would be no change of use. Mr. Wheeler asked Mr. DuBard (representing Airport Road Collaborative LLC) which statement/request was correct. Mr. DuBard stated that "there is no change of use being requested at this time". Mr. Wheeler also stated that a request for the assignment of lease to Airport Road Collaborative LLC had been received but that the LLC did not exist. After a short discussion with Mr. DuBard it was agreed that should the assumption be approved the LLC would be created prior to such approval. Additionally, Mr. Wheeler stated that according MVAC records, the VTC had not corrected previous violations issued by the West Tisbury Fire Inspector. Ms. McHugh stated that all violations except for one have been corrected and that the remaining violation would be cured upon installation of a door that is on order. DuBard's financials had been submitted per MVAC Policy, but as part of a PowerPoint presentation and not as a certified document. Mr. Werthwein stated that since the LLC would be assuming the Vineyard Tennis Center, Inc. the VTC financials should be required because the non-existent LLC would not have any financial history. Ms. McHugh and Mr. DuBard acknowledged that said financials would be provided to the Land Use Subcommittee prior to the assignment approval. Mr. DuBard and Ms. McHugh concurred that current staff would remain in place. Mr. DuBard stated that the business will remain unchanged as the VTC will be purchased and operated by Mr. DuBard.

MOTION: Mr. Werthwein that the Land Use Subcommittee recommends that the Martha's Vineyard Airport Commission consent to the assignment of the Vineyard Tennis Center, Inc. lease to a "to be created LLC" subject to 1) the LLC being created, 2) MVAC review the Vineyard Tennis Center Financials, and the 3) submittal of evidence of correction of all open Fire Inspection Violations.
